RESOLUTION.

A mass meeting of railway workers Ambala Cantt. was held on 8.4.74 under the joint auspices of Co-ordination Committee of Railway Workers representing all Associations/Unions of Ambala Cantt. in connection with 'DEMANDS WEEK' from 2nd April to 8th April 1974 as per decision of National Co-ordination Committee for Railwaymen.

The meeting demands that the Government should immediately start negotiation with the All India Action Committee for Railwaymen on the following common demands:-

1. (a) All railwaymen to be treated as industrial workers with full trade union rights including the right to negotiate.
2. (b) The working hours of Railwaymen shall not exceed 8 p.day.
3. (c) There should be job evaluation of all railwaymen through a scientific system to be followed by their reclassification and regradation with the need-based minimum wage as the wage for the lowest-paid worker.
- (d) Pending the completion of job evaluation and reclassification immediate parity in wages with those of workers in the Central undertakings, viz. HMT, BHEL, IISL, HAL etc.
2. Dearness allowance linked to the cost of living index with full neutralisation for every rise of 4 points in a six months period.
3. Bonus at the rate of one month's wages for the year 1971-72 and 1972-73.
4. De-casualisation of all casual railwaymen and their confirmation in service with all benefits given to them with retrospective effect.
5. Adequate and subsidised foodgrains and other essential commodities through departmentally-run shops.
6. All victimisation cases should be withdrawn.

It is considered opinion of this meeting that Indian Railways system is the biggest Transport industry of the country and its proper and efficient functioning is very vital for the economy of the country. The organised Trade Union movement on the Railways has to play the main role in running the railways efficiently. The management of the Railways is still being continued on the old colonial pattern in which the railway worker have no say.

Therefore this Meeting warns the Railway Ministry that if it failed to take decision of the National convention of Railwaymen seriously and come to the settlement by the 10th April 1974 on the above common demands of the Railway workers, they will have to face a UNITED GENERAL STRIKE on the railways and be entirely responsible for its consequences.

RESOLUTION ADOPTED ON 5.4.74 AT THE JOTI CONVENTION

This joint convention of the citizens and representatives of other organisation of Chittaranjan and Rupnaryanpur Area and the Railwaymen held on 5th April '74 congratulates the Railwaymen of Chittaranjan Locomotive Works for unifying their ranks and taking the decision to launch an indefinite strike on the various basic demands such as parity in wages with public sector undertakings, Bonus, full neutralisation, reduction of working hours, proper job evaluation, Decentralisation etc. in the event of the failure of the Railway Ministry to reach a negotiated settlement by 10th April, 1974.

As some of the demands in action the Railway Workers propose to go into action are in common interest to all the workers. Thus the convention feels that the Railwaymen's strike will have a direct impact and therefore other sections of the working population cannot remain indifferent.

- vi) All victimisation cases should be withdrawn.

2. All persuance of the resolution of the National Convention of the Railwaymen, this convention also resolves that for the preparation and furtherance of struggle on local basis, a co-ordination Committee of Railwaymen consisting of two representatives of all Organisation of workers and employees of C.L.W., whether industrial or categorywise, be formed. It is further resolved that the General Secretaries of four Unions viz. Labour Union, Karmachari Sahgha, Rly.men's Union and Workers' Union(INTUC) would act as Co-ordinator of the Committee for the time being.

5.4.74 - Besides Gate Meetings joint convention of Citizens & representatives of other organisations of Chittaranjan and Rupnarayanpur in the evening.

7.4.74 - Mass Rally.

8.4.74 - Wearing of Demand Badge & Mass Demonstration before G.M.'s Office.

R E S O L U T I O N

The Central Body Meeting of the All India Railway Stenographers' Association, Jhansi Branch held on date strongly deprecates the maltreatment of this category right from Ist Pay Commission, the New addition being Rly. Board's Circular letter No.E(NG) III-73-PC/52 of 4-3-74 purporting to attach one Senior Scale Stenographer with two Senior Scale Officers and reducing the strength of the Stenographers to 2/3rd of the Officers' strength.

Resolves that -

1. The Rly. Board's unilateral decision vide their letter under reference be withdrawn immediately as besides shrinkage of cadre and promotional chances it also aims at demoralising this category.
2. Each officer including junior scale should be provided with an independent Stenographer in appropriate grade.
3. The stenographers shall not comply with the impugned orders contained in Board's letter and will resist its implementation with all the vigour and strength at their command. If considered necessary, recognised/unrecognised Unions/Associations shall also be approached to muster their support in fulfilment of this objective.
4. AIRSA fully supports the demands of 96% upgradation in the clerical cadre and machine allowance to Typists as put forth by AIRMSA coupled with 6 popular demands jointly put forth by the recognised/unrecognised Unions/Category-wise Associations.

RESOLUTION ADOPTED IN THE NATIONAL CONVENTION  
OF CENTRAL GOVT. EMPLOYEES ORGANISATIONS  
CONVENED BY AIRF AT VITHALBHAI PATEL BHAVAN  
(CONSTITUTION CLUB) AT DELHI ON 15.3.1974.

March 15, 1974.

This Convention of Central Government Employees Organisations congratulates the Railwaymen for unifying their ranks and taking the decision to launch an indefinite general strike on the various demands such as parity in wages with public sector undertakings, Bonus, full neutralisation, reduction of working hours, proper job evaluation, etc. in the event of the failure of the Railway Board to reach a negotiated settlement by 10th April, 1974.

As some of the demands on which the Railway workers propose to go into action are of common interest to all Government employees, the Convention feels that the Railwaymen's strike will have great impact and, therefore, other sections of employees cannot remain indifferent.

Under the circumstances, the Convention appeals that the various organisations jointly and separately should attempt to complete their negotiations on the common and sectional demands well in time so that all the sections of the employees are also able to play their rightful role in the struggle of the Central Govt. Employees for settlement of basic, sectional and categorywise demands.

The Convention calls upon all sections of the employees to close their ranks, build up unity and gear up machinery to meet the challenge of the time.

RESOLUTION IN SUPPORT OF STATE EMPLOYEES  
ALL INDIA STRIKE ON 9TH APRIL, 1974,

State Government employees all over the country have been demanding over past one decade need-based minimum wage, full neutralisation of rising prices, vacation of victimisation and improvement of other conditions of service. The various committees and commissions appointed by State Governments as also the 3rd Central Pay Commission have frustrated the efforts of the State Govt. employees to secure these demands.

Their efforts particularly to attract the attention of the Central Govt. towards their pressing problems have gone unheeded. A mass petition signed by several lakhs of State Govt. employees was presented to the Lok Sabha on 18th April, 1973. Several thousand State Govt. employees from every corner of the country had assembled at the Capital to present the Mass Petition.

Meanwhile, the common people in general and fixed income group like Govt. employees in particular are the victims of the grave scarcity of food grains and other essential commodities and soaring prices. The sky-rocketting prices have caused serious erosion of the real income of the employees.

This Convention notes with deep concern that neither the Govt. of India nor the State Govts. have till now come forward to mitigate the burning problems of the State employees. Being unable to put up with this unbearable situation the National Executive of the All India State Govt. Employees Federation in its meeting on 18th and 19th February, 1974, held at Bhopal has called upon the 3 million State Govt. employees to observe one day's token strike throughout the country on 9th April, 1974 on the demands of bringing down sky-rocketting prices and ensuring adequate supply of food articles, need-based minimum wage, full neutralisation of rise in prices, 8.33% bonus, vacation of victimisation and stopping repressive measures, trade union rights, etc.

This Convention extends its whole-hearted support to this united strike struggle of the State Employees throughout the country and urges upon all workers and employees of the Central Government and Railways to mobilise their forces, hold solidarity programmes and firmly stand behind the State employees so that their strike on 9th April may become a challenging success.

This Convention also urges upon the Govt. of India and State Governments to appreciate the mounting discontent of the State Govt. Employees and take immediate steps to settle the problems immediately.

RESOLUTIONS ADOPTED IN THE WORKING COMMITTEE OF  
THE ALL INDIA SWITCHMEN, CABINMEN AND LEVERMEN *advisory*  
COUNCIL AT NAGINA (N.H.Y.) ON 15.2.1974.

...

Resolution No.1: Anomalies in the Grades of Switchmen.

...

Fundamentally, in all cases the Pay Commission has accepted the present scale of pay (i.e. pay plus D.A. plus D.P. with 3 interim reliefs) as the basis for its recommendation. In case of switchmen the present pay comes to Rs.264/- but the Pay Commission has recommended starting grade of Rs.260-400 for the Switchmen. In this way they are loser by Rs.4/-, while the employees of most of the categories have got more beneficial starts. In this connection, we would like to refer the case of Lower Division Clerks and ASMs. The LDCs have got a start of Rs.260/- as against their present pay of Rs.240/- and ASMs have got the start of Rs.330/- as against their present emoluments of Rs.313/- only.

At the time of discussions with the Pay Commission it was stressed that the posts of Switchmen should be compared with Cabin ASMs for the purpose of pay scales but these posts have been compared with Roadside ASMs, which is not justified. The Pay Commission in its report volume II (Part II) Chapter 36, paragraph No.104, has admitted that Cabin ASMs work in Cabins and their duties relate to train operation and shunting movements only. The same type of work and responsibilities are shouldered by the Switchmen in the small and big cabins on roadside stations. In fact the Switchmen perform greater important duties of SMs on 'C' Class Stations where no post of SM or ASM exists.

It is, therefore, demanded that the Switchmen should be placed in the scale of pay of Rs.330-560 which has been given to the lower grade Cabin ASMs.

Resolution No.2: Anomalies in the grades of Pointsmen,  
Levermen and Cabinmen.

...

The grades proposed by the Pay Commission are not commensurate with the heavy and hazardous duties and responsibilities performed by the Pointsmen, Levermen and Cabinmen for the safe reception and despatch of trains.

The Second Pay Commission (1957-59) in its report divided the Cabin Staff in about a dozen categories but it was expected that the Third Pay Commission will minimize the grades to two only but it has recommended five grades for the cabin staff which is against the policy of the Pay Commission for reducing the grades to the minimum possible.

The Third Pay Commission in its report has not put forth right arguments for the justification of the scales proposed by it. The Cabin Staff does not work under the SMs/ or ASMs. They work independently on the basis of their qualifications in regard to transportation work attained in the Railway Schools, but their punctuality and discipline is supervised by the ASMs/SMs.

Resolution No.3: Promotion of Switchmen to the post of Guard Grade 'C'.

\*\*\*

According to the Railway Board order the shunting Jamadars will be considered for the post of Guard Grade 'C' if the post of AYF is not available. Similarly, the Switchmen are also eligible for promotion to the post of AYF but they are not considered for the post of Guard Grade 'C'.

It is demanded that the Switchmen should also be made eligible for promotion to the posts of Guard Grade 'C' in the event of non-availability of post of AYF.

Resolution No.4: Provision of a leverman in the Cabins having more than 20 levers, with the Switchmen.

\*\*\*

On account of change in the mode of transportation from Steam to Diesel and Electric operated engines, the work of Switchmen has increased many fold. The Switchmen working in the Cabins having more than 20 levers have to undergo heavy strain of work to maintain safety.

It is, therefore, demanded that one leverman may be provided in each Cabin having more than 20 levers to assist the Switchmen to cope with the heavy load of work which which is supported to handle.

Resolution No.5: Gate allowance for cabin staff.

....

The duties of Gatemen are clearly explained in the separate chapter of General and Subsidiary Rules Part I and II. According to that the Switchmen, Levermen and Cabinmen are not supposed to perform the duties of gateman, but this work is being taken from the cabin staff without any extra allowance.

It is therefore, demanded that the cabin staff should be given the gate allowance where the duties of gateman are being taken from cabin staff in addition to their normal duties.

Resolution No.6: Provision of type-II accommodation and uniform as eligible to class III staff, to the Switchmen & Cabinmen Gr.I.

The Switchmen and Cabinmen Grade I are at present allotted accommodation of Class IV and the uniform supplied in the shape of Over-coat is also of Class IV type, whereas these posts are of Class III and are eligible to get Type II accommodation and Overcoat like that of other Class III staff like Brakesmen, Gr. M.110-130 and Despatch Clerk gr. M. 105-135.

It is therefore demanded that Switchmen, and Cabinmen grade I should also be allotted accommodation of Type II and superior overcoats as are paid to other Class III categories should be given to these categories of staff.

Resolution No.7:-

Promotion of junior class III staff  
as Ticket Collectors.

According to Sl.No.2415 the Cabinmen category has been made eligible for promotion to the post of Ticket Collectors as recommended by the Cl.IV Promotion Committee. The matter has already been taken up with the administration vide General Secretary's letter no. NRMU/1 dt. 10/10/72 & 11/10/72, but the matter is still pending finalisation.

It is demanded that implementation of the recommendations of the class IV Promotion Committee as accepted by the Rly. Administration may please be expedited.

Resolution No.8: Absorption of medically incapacitated Switchmen Gr. 125-155 to equivalent grade

The switchmen when medically incapacitated are absorbed in the class IV categories lowest grades whereas the Firemen Gr.'A' in the scale are absorbed in the higher grade of Rs. 110-180 on the posts of Fitters. The matter was taken up with the administration vide NRMU letter no. NRMU/1 dated 29/3/73.

It is therefore demanded that medically incapacitated switchmen should also be absorbed in equivalent grade as quoted above.

Resolution No.9:

Promotion of Levermen Gr.II, grade Rs. 75-95 and Pointsman grade 75-95 to the post of Brakesmen gr. Rs. 100-130.

According to the recommendations of the class IV promotion Committee and accepted by the Railway Board, Seniority of class IV in Transportation & Commercial Dep'tt. is to be pooled together for the purpose of promotion. The Levermen gr. II and Pointsman grade Rs 75-95 (Class IV) of the Transportation Department are not considered for promotion to the posts of Brakesmen, ~~alongwith~~ alongwith the Commercial Class IV staff.

It is demanded that class IV Levermen gr. II and Pointsmen in grade 75-95 in Transportation Department should also be considered alongwith the Commercial Class IV staff for promotion to the post of Brakesmen.

Resolution no.10:

Provision of gr.I Cabinmen instead of Cabinmen gr.II or Levermen Gr.I in the cabins having Log Registers & Private Numbers sheets.

At present the cabins having Log Registers and Private Number sheets are manned with Cabinmen Gr.II or Levermen Gr.I in gr. Rs. 80-110. The duties assigned to them are of greater responsibility which should be shouldered to the Cabinmen Gr.I Gr. 105-135.

It is therefore demanded that cabins having Log Registers and Private Number Sheets should be named by Cabinmen grade I in scale Rs. 105-135.

Resolution no.111

8 Hours duty instead of 12 hours  
for Cabinmen & Levermen.


According to the decision of the Mian Bhay Tribunal, the Cabinmen and Levermen are supposed to perform 8 hours duty in a day but at many place they are supposed to perform about 12 hours duty which is against the Award given by the Tribunal. Due to dieselisation and electrification the work load of these categories has considerably increased and in view of safety measure it is not correct to take work from these categories for 12 hours a day.

It is therefore demanded that the award given by the Tribunal as stated above should be completely implemented and the categories of cabinmen and levermen should not be asked to perform duty for more than 8 hours a day.

Resolution no.12: Clarification of cabinmen & levermen etc.on the Railway.

According to the Railway Board orders as contained in their letter no. PC-60/PS-5/TC/1 dt. 21/6/61 all points men were designated as Levermen gr. I and II according to the seniority in Northern Railway, Lucknow, Allahabad and Moradabad divisions, but this has not been done in Ferozepore, Bikaner, Jodhpur and Delhi divisions. The pointmen in existence in these divisions are not taken the work of their duty but they are asked to perform the duties of Shunt-men, Token Porters, Station Porters etc. be asides their normal duties. These pointmen are getting the benefits of their promotion as is extended to Levermen of ND, LKO & MS divisions for a chance of promotion from Switchman, Cabinmen, Levermen to ASI.

It is therefore demanded that the posts of pointmen over Delhi, Ferozepore, and Jodhpur, Bikaner division should be designated as Levermen Gr. I and Gr. II according to their seniority so that they may also get the same benefit as it available to their counter-parts in other divisions.

NATIONAL CONVENTION AT MADRAS.

RESOLUTION NO.I

This convention of AISMA held at Madras on 15th and 16th February 1974 condemns the ghastly and unprovoked atrocities perpetuated by the Government of Gujarat & Maharashtra on the people demanding food and clothing and condoles for the martyrs who laid down their lives for the cause of the people.

This convention sends its fraternal greetings to the toiling people of Gujarat & Maharashtra who created history in the mass movement in the beginning of 1974 by braving the brutal shooting of the police CRPF and the Army deployed by the present regime.

This convention also condoles the death of comrade Muzafer Ahmed, the veteran trade Unionist and Ex-Vice-President of the AITUC and leader of the toiling masses of our country and gives respect to his beloved memory.

This convention condoles the sad demise of National Professor Satyan Bose and great Literatur Syed Mustafa Ali and other colleagues in different parts of India and conveys deep sympathy to their bereaved families.

RESOLUTION NO.II

This Special Convention of AISMA held at Madras under the Chairmanship of President H.S. Chatterjee notes with serious concern the Anti-labour policy of the Govt. of India towards its own employees in not conceding their vital demands relating to new wage structure on the basis of need-based Minimum Formula as adopted in the 15th Indian Labour Conference, stabilising price line, D.A. linked to consumer price index, Bonus, Decasualisation, full protection of grade and rank for medically declassified staff, full Trade Union rights and reinstatement of all victimised Trade Union workers, repeal of all draconian acts, withdrawal of Emergency and DIL, stop deployment of Territorial Army against Trade Union Movement, scrap ban on recruitment in the Railways for employment potential, withdrawal of all means of automation as labour saving devices, political rights including right to contest in Elections, Labour participation in Management through direct election amongst employees, supply of essential commodities, Bi-partite agreement for wages, confinement of duties to 8 hours per day etc. etc.

This convention notes the ever growing resentment expressed by all sections of employees of the Government, together with the entire working class of our country in a state of great enthusiasm to fight out the standing menace created by the ruling class in their bid to pauperise our people.

This convention, therefore, finds its transparent as anything to launch a united All India Strike till the demands are fulfilled by the Government of India. This Conference calls upon the Railwaymen and other Central Government Employees to be prepared to join the strike. In a massive strike struggle of All-India Character, all organisations should mutually form one joint Council of Action to evolve Joint-leadership for joint campaign, serving of strike notices to their respective authorities and to fix a common suitable date for the purpose.

In the opinion of this convention, 11 A.M. on 1st May, 1974, the May Day would be most appropriate on overall considerations - and most fervently hopes that all other sister organisations serving the cause of Govt. employees would find good and sufficient reasons in accepting this date for declaring a General Strike.

It should be noted that the joint council of action should act and provide collective leadership in the matter of preparation, conduction and governing of the strike and no individual organisation or personnel will act in any negotiation before during or after the strike and for calling off the strike.

This Convention gives the clarion call to its members and all other Railwaymen to stand heroically and to make the greatest sacrifices in the fight to wrench their just and reasonable demands from the unwilling hands of the Government of India.

### Resolution No.3.

#### Charter of demands:

##### 1). Hours of work:

- a). SMs/ASMs shouldering commercial duties at the rate of 15% of pay.
