MINUTES OF THE MEETING OF THE AITUC WORKING COMMITTEE
HELD IN NEW DELHI ON AUGUST 31, 1961

PRESENT: S.S.Mirajkar, President; S.S.Yusuf, Parvathi Krishnan, Vice Presidents; S.A.Dange, General Secretary, K.G.Sriwastava, Indrajit Gupta, Satish Loomba and K.T.K. The following agenda was adopted:

- (1) Confirmation of the Minutes of the last meeting
- (2) Finalisation of the proposals for agenda of the General Council meeting
- (3) Appointment of Credential Committee ~~and~~ for considering applications for affiliation.
- (4) Share of affiliation fees to STUCs - procedure to be adopted for calculation.

(1) The Minutes of the last meeting of the Working Committee were read and confirmed.

(2) A Credential Committee consisting of Coms.K.N.Joglekar, Kallat Krishnan and A.C.Nanda was appointed to scrutinise the applications for affiliation and report. *

(3) Agenda of the General Council was discussed and the following items were proposed:

- i) General Report
- ii) Fifth World Trade Union Congress
- iii) Tagore Centenary Peace Festival
- iv) Resolutions

(4) After a discussion on the procedure for calculating share of affiliation fees to STUCs, it was resolved that the entire affiliation fees, including STUC quota should be remitted by unions directly to the AITUC and no amount is deductible by STUCs. STUC quotas will be settled monthly by the AITUC.

The Committee met for a short session on September 2, 1961 to consider the Credential Committee's Report. As recommended by the Credential Committee, it was resolved to grant affiliation to 22 unions. 25 unions were given provisional affiliation, pending submission of required documents and affiliation fees.
